The Second Separate Board Session focused on a discussion of the Pharmacists Assessment for Remedial Education [PARE] which will be available from the National Association of Boards of Pharmacy [NABP] in 2012. This will allow Boards of Pharmacy to utilize this for pharmacists who have gotten into trouble, pharmacist who have been out of practice and wish to reinstate or pharmacists that have been working in other fields and now wish to activate their pharmacist licenses. PARE will give both the Board and the pharmacist an assessment of what education would be necessary for these individuals to be able to reenter the profession successfully.

Board Session

8:30AM – 9:00AM [Community Pharmacy Accreditation Update](#) - Malcolm Broussard,
R.Ph, President, NABP

The third separate session centered on a discussion of Community Pharmacy Accreditation. Carmen Catizone explained for Malcolm Broussard that this program was designed to help states who find resources are lacking for proper inspections of retail pharmacies and for confidence when licensing pharmacies across state lines. Continuing quality improvement programs are required under the accreditation program.

In response to questions, Carmen pointed out that the inspections for community pharmacy accreditations would be conducted relevant to local laws. If, similar to joint commission accreditation and CMS accreditation, the pharmacy must follow local laws in order to receive accreditation. Similarly standards for technicians would be assessed relative to local law requirements. For example, if the local law required three technicians or fewer per pharmacist, that would be the standard for the inspection in that state. Should the state require two technicians or fewer per pharmacist, it would be the standard for that one particular state's accreditation.
