NDPhA President's Message

NORTH DAKOTA

Colleagues,

One of the perks of being president of the Association is that you get to sit on the North Dakota State College of Science (NDSCS) Pharmacy Technician Advisory Council. I was fortunate to attend my first meeting this month and the information presented was very informative, but a bit sobering. The good news is that NDSCS is committed to educating pharmacy technicians who are ready to enter into practice. The unfortunate news is that enrollment is down. The other unfortunate reality is that the collaboration with Bismarck State College (BSC) has not taken off as anticipated. This was viewed by many as an excellent opportunity for the training of pharmacy technicians to fill the demands seen in the western part of North Dakota. Perhaps this is only signs of initial growing pains for the program.

I, like most other pharmacists, have become dependent on having an excellent pharmacy technician on staff to assist with my workload. Sharon would probably say that she has taken over my workload and there is some truth in that assertion. The reality is that this has allowed me to focus on other aspects of my job which would not be possible without her assistance. (Plus she provides much better customer service than I ever did!) Could I do my job without the assistance of a pharmacy technician? I could, but the quality and service of our department would suffer. Having well educated pharmacy technicians is not a luxury. It is a necessity if we are to continue to advance the practice of pharmacy and the expansion of services for our patients. For me, the key portion of that statement is "well educated."

I have also been fortunate to serve the citizens of North Dakota by my time spent as a member of the North Dakota Board of Pharmacy. It was during the beginning of my first term that the Board dealt with the issue of the amount and type of training that we wanted for pharmacy technicians who would eventually practice in our great state. Bill Grosz was insistent, and rightfully so, that we have pharmacy technicians who could enter into any practice setting. Now there are rumblings of a two-tier education system for pharmacy technicians. This would entail a change in the certification requirements in which there would be an entry level pharmacy technician versus an advanced level pharmacy technician. The question that the profession in our state must answer is "do we want this type of two-tiered training and certification of pharmacy technicians?"

A balancing act while pursuing the pharmacy profession

In spring of 2017, Jantze Lewis took her last final exam on Friday. Her husband received his pharmacy degree from North Dakota State University on Saturday. Then she gave birth to the family's third child the following Wednesday.

"At least she waited until after finals," Jantze said, understatedly, of her baby girl's arrival.

Jantze is in her second year in NDSU's professional pharmacy program. She has a full schedule with school, family and work, but she knows she has the support of her professors and that the balancing act will pay off with a rewarding career.

She chose to study pharmacy because of her life-long interest in science and a job at a pharmacy. She likes mysteries and once considered a career in forensic science. However, she discovered she wanted to be a pharmacist after working at a pharmacy.

"I like being able to help people find what they need and figure out how to use their medications," Jantze said. "Working in a pharmacy, I'm able to apply what I'm learning as I'm learning it."

Jantze's husband, Steven, started NDSU's pharmacy program first. He chose the program for its reputation. Ninety-five percent of the students who graduated from the program from August 2015 to May 2016 are employed.

It also helped that Fargo was close to family who had relocated to Fargo from Burlington, North Dakota, near Minot.

Jantze started her education at Minot State University and then transferred to NDSU when Steven began taking classes. She

completed her degrees in chemistry and criminal justice while starting her prerequisites for the pharmacy program.

"I get a lot of hands-on experience here," Jantze said. "I really feel like they do a good job getting us ready for the actual workplace."

Faculty and staff also were supportive and flexible with the couple's family responsibilities. In the spring of 2017, Steven was doing clinical rotations in Minot, while Jantze was going to school, working and taking care of two children—all while pregnant.

Post-graduation, Steven is a floating pharmacist at different locations in the region, joining the ranks of NDSU-educated pharmacists. An estimated 90 percent of the practicing pharmacists in North Dakota are NDSU alumni.

Jantze said it's strange to not have both her and Steven going to school this fall. But she was ready for the fall semester to begin.

She is taking 18 credits of coursework and is excited to begin learning more about vaccinations and how specific medications target diseases. The program will prepare her to become certified in North Dakota to administer vaccines.

And she'll do it all while balancing family, work and school.

"My advice is to be organized and have a good support system," Jantze said. "I get a lot of support from our daycare and staff and faculty. They've been great working with my husband and me."

NDSU School of Pharmacy developing ways to assist pharmacists in increasing adult immunization rates.

NDSU researchers have received a nearly \$10,000 North Dakota Department of Health grant to help increase adult immunization rates. The team is developing a targeted education program for state pharmacists. The work includes a survey recently sent to all pharmacists in North Dakota.

Elizabeth Skoy, associate professor of practice in pharmacy practice, is leading the effort. Collaborators include Michael Kelsch, associate professor of practice and vice chair in the School of Pharmacy, and Dr. Paul Carson and Kylie Hall from the Center for Immunization Research and Education in the NDSU Department of Public Health.

The grant's title is "Increasing North Dakota's Adult Vaccination Rates," and the project consists of developing and delivering a minimum of three one-hour pharmacybased education modules to pharmacists within the 20 counties with adult immunization rates below 30 percent for pneumococcal and shingles. The counties are primarily in the western and south central parts of North Dakota.

State law allows authorized pharmacists to provide any immunization to individuals 11 years and older. Currently, 364 registered North Dakota pharmacists are authorized to provide immunizations. That number represents only 41 percent of state pharmacists, providing less than 9 percent of all administered pneumococcal immunizations to adults 65 and over and approximately 30 percent of all zoster vaccines to adults 60 year and older, according to the North Dakota Immunization Information System.

The researchers are surveying approximately 900 pharmacists across the state and making phone calls to pharmacies in counties with low adult immunization rates.

"Our goal for the survey is to conduct a needs assessment to determine physical and educational resources needed for pharmacists regarding adult immunizations. Pharmacists are arguably the most accessible health care provider, especially in some of our more rural areas of North Dakota," Skoy explained.

"Our goal from the grant awarded by the North Dakota Department of Health is to increase adult immunization rates through targeted pharmacist education. However, before we can develop the educational materials and resources, we need to find out what pharmacists would find to be most helpful and perceived barriers to immunization delivery."

Former NDSU Associate and Interim Dean of Pharmacy Remembered

Dr. Stephen Hoag served as associate and interim dean in the NDSU School of Pharmacy. A celebration of his life was held in Duluth, Minnesota this fall.

A celebration of life was held on October 28 in Duluth, Minnesota, for Stephen Guttormur Hoag, 73, former associate dean and interim dean of the NDSU School of Pharmacy. He passed away on October 16, 2017. A member of the Class of 1967, Hoag received a degree in pharmacy from North Dakota State University. He received his master's degree and Ph.D. in clinical pharmacy from Purdue University.

From 1978 to 1981, Hoag served

as chair of the Department of Pharmacy Practice at NDSU. He then served as associate dean of the School of Pharmacy from 1981 to 1987 and as interim dean. He also served in dean and provost positions at the University of Minnesota, Drake University, and Ohio Northern University. He was a member of Kappa Psi Pharmaceutical Fraternity.

Hoag was a graduate of East High School in Duluth, Minnesota. According to his obituary published in the Duluth News Tribune: "He relished and embraced the many successes of his family, faculty and colleagues."

One colleague impacted by Dr. Hoag was Dr. Donald Miller, professor of pharmacy practice at NDSU. "Steve was a great mentor to me when I got hired," said Miller, a previous Al Doerr Service Award recipient for outstanding public and professional service to pharmacy.

Dr. Hoag is survived by his wife, Jill, sons Arthur, and Joel, and extended family.

In Hoag's obituary, the family requested that in lieu of flowers, memorials may be made to the Colleges of Pharmacy at North Dakota State University, the University of Minnesota, Drake University, Ohio Northern University or the Alzheimer's Association.

USP Chapter 800 Hazardous Drugs / Handling in Healthcare Settings

The recent big news in the practice of Pharmacy was the decision by the United States Pharmacopeia to delay the implementation of USP 800 until December 2019. This delay in implementation will provide ample time for Boards like ours and pharmacies to determine a response to this new chapter.

USP 800 will affect not only pharmacies across the state but also healthcare facilities as well.

USP 800 provides guidance for personal handling of hazardous drugs, including the use of personal protection equipment and proper communication, training, transport, package labeling and proper disposal. It also offers specifications for the building environment for handling these "hazardous" drugs. For many pharmacy locations not compounding, the USP 800 standard may not require modification of their space. However, pharmacies that may conduct hazardous drug compounding may need to make extensive changes to come into compliance with the standard.

The Board of Pharmacy has been talking about USP 800 Standards, including if we are going to adopt the standard or modify our existing current Rules to address the new standards relative to hazardous drugs. At a minimum, there are certainly improvements that can be made in our profession relative to notification and educating our staff and employees about the dangers of hazardous drugs and how to correctly limit our exposure.

For many of our health system pharmacies, the modification of space must be completed to accommodate the USP 800 Standards, as it will be the enforceable standard of both JCAHO and CMS accreditation. As things progress, compliance will certainly involve education and setting policies and procedures around how these hazardous drugs will be safely handled to minimize risk, according to where the drug falls on the NIOSH list.

I encourage you to take the time to educate yourselves on what implications USP 800 would mean to your practice and practice site. Please keep the Board informed on what you feel is the appropriate path moving forward in progression of developing an approach to ensure limited exposure to these potentially harmful substances. The Board will more than likely create a task force to assist the Board with the pros and cons of USP 800 and to determine what the right path is for our profession in response to these new standards.
